This is the last Will
and Testament of my William Birch of Charlotte-
Street Bloomsbury in the County of Middlesex Esquire
which I do make and declare in manner following
(that is to say) whereas by the Settlement made on my
Marriage with my dear wife Sally Power is reserved
to me to dispose of all that my Honor and Estate
of Calderott with the Advowsons and Appurtenances
thereto belonging in the County of Berks amongst my
Children and whereas my eldest surviving son
Richard has been so considerable a support to my
two Deceased Sons I therefore think him best entitled
to stand in their place and in pursuance and
Exercise of the power aforesaid I do by this my
will direct limit and appoint our undivided Sixty
or equal half part of all the Honor and other
Advowsons and Estate the power of appointment
whereof is reserved to me by my Marriage Settlement
from and after the Death of the Survivor of my
said dear wife and myself to be and remain to the
only use and behoof of my son Richard Comyns
Birch his Heirs and Assigns for ever our undivided
sixth part or share thereof to be and remain to
the only use and behoof of my Daughter Marianna
Churchill her Heirs and Assigns for ever our other
undivided sixth part or share thereof to be and
remain to the only use and behoof of my son John
Brenton Birch his Heirs and Assigns for ever and
the remaining undivided sixth part or share thereof
to be and remain to the only use and behoof of
my Daughter Selina Fitz Roy Birch her Heirs
and Assigns for ever I give to my Grand Daughter
Marianna the only Child of my late son William
my Diamond Clutch Ring in Token of my affectionate
 regard for her in point of fortune she is amply
provided for and I earnestly wish that happiness
may attend her my large Emerald Ring heretofore

belonging to my friend Paris Taylor I give to my said
 son Richard and I give divers and bequeth unto my
 said son wife all and singular other my real and
 personal estate whatsoever and whosoever to hold to
 her her heirs Executors Administrators and assigns
 according to the nature thereof and I do nominate
 and appoint her sole Executrix of this my will and as
 to all Estates and Property whatsoever held by me in
 trust for any person or persons whatsoever I give
 devise and bequeth the same and every part thereof
 unto my Disphor John Birch of Chantry Lane
 his heirs Executors and Administrators according to
 to the nature thereof for the purpose of raising
 the several trusts into Execution and to be disposed
 of as may be found necessary in my said Disphor
 being best acquainted with such several Courts and
 most able to relieve my family from Distress or
 trouble in respect thereof the witness whereof I have
 to this my last will and Testament contained in one
 sheet of paper set my hand and seal this twentieth
 day of March in the year of our Lord one
 thousand eight hundred - 10th March 25 - signed sealed
 published and declared by the said William Birch
 the testator as and for his last will and Testament
 in the presence of us who in the presence of him and
 of each other and at his request subscribed our
 names as witnesses - John Boehman - Geo. Sanderson

This Will was proved at London the second
 day of April in the year of our Lord one thousand
 eight hundred before the worshipful Charles ne
 Coote Doctor of Laws surrogate of the Right
 Honourable Sir William Wynne Knight also Doctor
 of Laws Master Keeper or Commissary of the
 prerogative Court of Canterbury lawfully constituted
 by the oath of Sally Birch widow the Debit of
 the testator and the sole Executrix named in the
 said will to whom administration of all and
 singular the Goods Chattels and Credits of the said
 testator was granted having been first sworn by
 her to administer
